Towel, curtain, cushion, cushion cover, neck pillow, quilt, bed set (pillow case and quilt cover), fitted sheet, table cloth, bathrobe, blanket, washing machine cover, produced from woven fabric or knitted fleece (including micro, PV, coral, flannel, lamb, micro coral, shu velveteen and jacquard coral fleece) made of 100% polyester, white, disperse dyed and disperse printed, partially with antistatic and antipilling finishing, including accessories (nonwoven fabric, filling material made of 100% polyester or 100% recycled polyester [recycled content 100%: polyester 100% post-consumer material made from PET bottle flakes] fibre in white or polystyrene bead in raw white, printed label, embroidery and sewing thread, zipper and elastic tape) – Blanket, cushion, cushion cover, quilt, quilt envelop, pillow, pillow envelop, bathrobe, rug, seat pad, washing machine cover, bed sheet, fitted sheet, table runner and sofa cover made of PES, PES/PAN plush fabrics, white, piece-dyed, top-dyed, discharge-dyed, printed, or PES imitation rabbit fur or faux rabbit fur, white, piece-dyed and disperse printed, including accessories (recycled PES staple fibre, PES sewing thread, zipper, PES woven band, printed label and PES woven label) – all based on materials pre-certified according to STANDARD 100 by OEKO-TEX®

The results of the inspection made according to STANDARD 100 by OEKO-TEX®, Annex 6, **product class II** have shown that the above mentioned goods meet the human-ecological requirements of the STANDARD 100 by OEKO-TEX® presently established in Annex 6 for products with direct contact to skin.

The certified articles fulfil requirements of Annex XVII of REACH (incl. the use of azo colourants, nickel release, etc.), the American requirement regarding total content of lead in children's articles (CPSIA; with the exception of accessories made from glass) and of the Chinese standard GB 18401:2010 (labelling requirements were not verified).

The holder of the certificate, who has issued a conformity declaration according to ISO 17050-1, is under an obligation to use the STANDARD 100 by OEKO-TEX® mark only in conjunction with products that conform with the sample initially tested. The conformity is verified by audits.
